# Economic Development Trust Announces \$90,000 Available for Final Round of Grassroots Funding for 2025

**August 18, 2025** – The Six Nations of the Grand River Economic Development Trust (EDT) is pleased to announce that \$90,000 is available for the final round of grassroots applications for 2025. This is a result of annual distributions of surplus profits from the operations of the Six Nations of the Grand River Development Corporation (SNGRDC).

This round of funding will be available to grassroots applicants only. Applications will be released on <a href="www.sixnationsedt.ca">www.sixnationsedt.ca</a> on August 25, 2025. The final application deadline is Friday, September 12, 2025, at 4:00pm.

Organizations that are eligible to apply for grassroots funding include established volunteer groups or organizations that do not have regular employees. This application is designed for those who have a group or organizations who work on a task or project without salary or wages, would not have a registered board of directors, and may not have audited financial statements to provide. The maximum amount of funding available to each grassroots applicant is \$15,000.

Since 2016, the EDT has invested over \$24 million into the Six Nations community. The EDT's funding is made possible through annual distributions of surplus profits from SNGRDC. The Economic Development Trust (EDT) is the mechanism in which surplus profits generated by Six Nations of the Grand River Development Corporation (SNGRDC) are invested into the Six Nations community for the collective benefit of its members. This model of distribution was a direct result of the 2011 community engagement study "We Gather Our Voices". Following the launch of SNGRDC's remodeled governance structure in March 2023, the mandate of the EDT has become a function of the SNGRDC Board of Directors, which will continue to provide funding for community investment.
